JOB DESCRIPTION

Job Purpose: To contribute to and enhance the research, teaching and enterprise activities of the School of Social, Political and Geographical Sciences in the area of media and crime.

The post holder will be a member of the new Centre for Research in Communication and Culture (CRCC), which will develop the School of Social, Political and Geographical Sciences' outstanding international reputation for research and teaching in these areas. Membership of the Centre will range across all departments in the School. This post will be located in the Department of Social Sciences.

Job Duties:

Research

- To pursue a personal research programme consistent with the research priorities of the Centre for Research in Communication and Culture (CRCC).
- To secure external research and / or impact-related funding.
- To supervise and manage research projects.
- To publish the outcomes of research in outlets of leading international standing.
- To attend and contribute to major international conferences.
- To supervise postgraduate students at Masters and Doctoral levels.
- To collaborate in research initiatives with colleagues in the School and more widely across the University including with colleagues in Research Schools.
- To collaborate in research initiatives with other HEIs and other relevant bodies.
- To produce an annual personal research plan.
