Job Description

Job Grade: Specialist and Supporting Academic, Grade 6

This is an exciting opportunity for a social researcher with a background in memory studies, cultural sociology, social history and/or media and communications studies to join the five-year project 'Migrant Memory and the Post-colonial Imagination (MMPI): British Asian Memory, Identity and Community after Partition' funded by the Leverhulme Trust, led by Dr Emily Keightley. The research involves working with the Bangladeshi community in Tower Hamlets to explore cultural memories of the 1947 Partition of India, the ways in which they are communicated across time and space, and the role of these memories in the development of contemporary community identities.

The successful applicant will be a social researcher with experience in qualitative social research methods, and a background in memory studies, cultural sociology, social history, media and communications studies or a cognate discipline. She/he will need to be comfortable conducting research in multicultural community settings. Experience of conducting research with the South Asian community, and/or participatory action research, and or empirical memory studies research are also desirable, as is particular interest in the social and cultural construction of identity.

The successful candidate will primarily work with Dr Emily Keightley (Department of Social Sciences), and will be linked to the Institute for Media and Creative Industries at Loughborough University London. She/he will also collaborate closely with the Arts and Culture Officer, Tower Hamlets Council. The successful candidate will work in a small group based at Loughborough in London. They will be assisted in data collection activities by a 0.5FTE research assistant (from year two onwards) and will work in collaboration with two doctoral students. This team will be mirrored by another research team working with the South Asian community in Loughborough.

Job Purpose

To conduct social research with the Bangladeshi community in Tower Hamlets to explore cultural memories of the 1947 Partition of India, the ways in which they are communicated across time and space, and the role of these memories in the development of contemporary community identities.

Job Duties

Project Specific (management)

- Take shared responsibility for overall project design and management;
- Manage and coordinate specific areas of qualitative research;

- Take responsibility for negotiating and maintaining research contacts and relationships with research partner organisations;
- Manage qualitative research materials and archiving;
- Take responsibility for the analysis and presentation of findings;
- Assist with the management and organisation of project meetings;
- Attend and contribute to meetings with project partners and other stakeholder organisations;
- To work in collaboration with PhD students and the research assistant (from year two onwards) based at Loughborough University London;
- To liaise with the project team based at Loughborough University;
- Report to the Principal Investigator;
- Share research progress and issues with the Principal Investigator;
- Attendance and input at regular internal meetings;
- Manage and develop online materials, blogs and social media as appropriate.

Project Specific (research)

- Conduct literature based searches and collect background information on the research area;
- Work with partner organisations to facilitate access to Bangladeshi community and to collaborate on programmes of cultural activities in the area;
- Negotiate and follow up research contacts;
- Design and undertake data collection using qualitative interviewing techniques, participant observation, and programmes of participatory cultural activity;
- Analyse qualitative research data;
- Conduct two to three short periods of fieldwork in South Asia as required (year three);
- Transcribe interviews and prepare data for archiving;
- Engage with various stages of data analysis;
- To contribute to the design and delivery of project events and associated scholarly activities (e.g. research symposia and visiting scholar events);
- Manage the dissemination of online materials such as blogs and social media;
- Assist in the development of materials for knowledge transfer and networking;
- Attend and take part in continual professional development events;
- Author / co-author seminar and/or conference papers based on the research;
- Present /co-present at conferences, seminars and related events;
- Author / co-author scholarly articles based on this work.
