Job Title: Beauty Therapist

Purpose:

To ensure the efficient day-to-day running of the therapy centre, by providing high standard treatments along with a friendly attitude towards clients and guests. To be responsible for the cleanliness and hygiene of the treatment rooms.

Main duties:

- To carry out all beauty and skin care treatments, at the highest standard possible.
- To give the best advice possible to clients and prescribe retail products for homecare.
- Work as a team and individually to help the department achieve sales targets.
- To be flexible and make sure there are enough therapists to cover shifts and day spa bookings.
- To be reliable and punctual due to the nature of the job and direct contact with customers.
- Be prepared to take part in any staff training sessions and attend any courses to update your knowledge. Attend meetings when required to discuss promotions and business.
- To book in treatments on the computer, and use the computer to take payments.
- Help to change the cabinet displays once a month or when a new promotion begins. To keep the retail areas clean and tidy.
- Clean the therapy room on a daily basis, restock towels, check trolleys have all the products needed.
- Inform Manager of anything that needs ordering from Dermalogica, Ellisons, Mavala etc.
- Enter all sales onto the form so that you get commission.
- To undertake such other duties as may be reasonably requested and that are commensurate with the nature and level of the post
